WHEREAS, Town Council wishes to readopt and restate the tax rates for fiscal year 2014 for the upcoming fiscal year 2015.

NOW, THEREFORE, be it ORDAINED by the Council of the Town of Boones Mill, as follows:

Sec. 5. Tax Rates.

The applicable levy for fiscal year 2014-2015 and subsequent years unless altered by Town Council shall be:

Real Estate:	\$0.12/\$100 assessed value
Personal Property:	\$0.40/\$100 assessed value

And, the Personal Property Tax Relief Percentage shall be: 45%

All other tax rates shall remain in effect according to the last prior action of the Town Council for each tax or fee.

This Ordinance shall be in full force and effect on July 1, 2014. All ordinances or parts of ordinances in conflict with the provisions of this Ordinance shall be, and the same hereby are, repealed.
